The Toro Company and its affiliate, Toro Warranty Company, pursuant to an agreement between them, jointly warrants to the owner each new piece of irrigation product (featured in the current catalog at date of installation) against defects in material and workmanship for a period described herein, provided they are used for irrigation purposes under manufacturer's recommended specifications.

During the warranty period, we will repair or replace, at our option, any part found to be defective. Your remedy is limited solely to the replacement or repair of defective parts. This warranty does not apply (i) to Acts of God (e.g., lightning, flooding, etc.) unless specifically listed under the Extended Lightning Protection Warranty provided herein; or (ii) to products not manufactured by Toro when used in conjunction with Toro products; or (iii) where equipment is used or installation is performed in any manner contrary to Toro's specifications and instructions, or where equipment is altered or modified.

Return the defective part to your irrigation contractor or installer, or your local distributor who may be listed in your telephone/web directory under "Irrigation Supplies" or "Sprinkler Systems", or contact The Toro Warranty Company, 5825 Jasmine Street, Riverside, California, 92504, phone (877) 345-8676, for the location of your nearest Toro distributor, or outside the U.S., call (951) 688-9221.

Neither Toro nor Toro Warranty Company is liable for indirect, incidental or consequential damages in connection with the use of equipment, including but not limited to vegetation loss, the cost of substitute equipment or services required during periods of malfunction or resulting non-use, property damage or personal injury resulting from installer's actions, whether negligent or otherwise. Some states do not allow the exclusion of incidental or consequential damages, so this exclusion may not apply to you.

All implied warranties, including those of merchantability and fitness for use, are limited to the duration of this express warranty.

Grounding

The Toro Warranty for Irrigation Controllers is void if controller is not properly grounded per instruction manual. A good ground source is a mandatory component of overall surge protection for Toro Irrigation Control Systems. Grounding electrode(s) should be placed at each automatic controller or controller group locations. The resistance to the grounding electrode should not exceed 10 Ohms when measured with a Megger Earth Resistance Testing instrument or equivalent. It is the responsibility of the installer to connect all electronic irrigation equipment for which he is responsible to earth ground in accordance with Article 250 of the National Electrical Code (NEC). Even with optimum grounding, neither Toro nor Toro Warranty Company are liable for product failures due to acts of God (i.e., lightning, flooding, etc.), and these failures are not covered by warranty.

Toro Irrigation Division Policies and Procedures

Orders

Orders must be placed in bag/carton quantities as indicated. Orders that do not meet these criteria will be rounded up to full carton quantities prior to shipment and noted on your order confirmation.

Minimum Order

\$100.00 Net. This minimum applies to whole goods orders only and not to orders for parts or literature (\$25.00 minimum for parts only).

Late Charge

All invoices not paid by the net due date will be subject to a service charge of the lesser of 1.5% per month (18% annual percentage rate), or the highest rate then permitted by applicable law.

Credit Terms

Dating terms, as well as all open account credit terms, are made available to those customers which the company's credit department determines to be credit-worthy. Customers may participate in buying programs or enjoy open account dating terms only as long as such credit-worthiness, as determined by the company, is maintained.

If such credit-worthiness is not maintained, dating terms on future purchases may be revoked, or all outstanding customer obligations under open account shall become immediately due. Either action may be taken at the company's option and upon written notice to the customer. If an unresolved credit issue extends beyond 30 days, open orders may be subject to shipment hold or cancellation.

Freight Terms

US Standard Orders:

Surface freight charges for all orders of \$1,200 USD net or higher are pre-paid by The Toro Company. Distributors may combine Toro and Irritrol brand products to meet the minimum pre-paid threshold. A 9% shipping and handling charge will be added to shipments of less than \$1,200 USD net. **Please note:** Authorized Unique Lighting Systems distributors may combine deliveries of irrigation and/or lighting products to meet per-paid freight thresholds.

Canadian Standard Orders:

Orders for the Canadian marketplace will be pre-assigned a standard weekly ship day, with an ordering cut-off time of 12:00 noon Central Standard Time two days prior. Orders received after this time can either be held until the following week or requested "RUSH" (see next section).

There is a \$3,500 USD net minimum per shipment value in order to receive free freight. A member of the Customer Service Team will notify you on the "cut-off day" if your total outstanding shipment value does not qualify for the free freight minimum. If your order is under the \$3,500 minimum, you will be presented with three options:

1. Ship "as-is", though you will be responsible for freight cost;

2. increase your order size to \$3,500 USD to have it shipped prepaid;

3. postpone shipment until the following week to provide ample time to increase the total order value to \$3,500 USD.

Customer Service must receive an immediate response as to the above-noted options. If no response is received, we will postpone shipment until the following week as the default.

Freight charges for emergency order shipments are to be paid by the Distributor. This includes Next-Day delivery, Second-Day delivery, and any other premium service(s) or other special delivery needs.

Special Order items

Special Order items may not be returned for any reason.

Claims for Shortage

All claims for shortage should be made in writing, by fax or phone to our Order Services Department within 30 days of receipt of goods. *If not reported within 30 days, your claim may be refused.*

Product Return Policy

Products returned (other than for defects) must be pre-approved by Toro Management. For details, contact your local Toro Regional Sales Manager. A 15% minimum stocking charge will be applied.
